Sir,

With reference to the letter and subject cited above this is to intimate that you have applied for issuance of Fire Safety Certificate in respect of Kendriya Vidyalaya, At-Tarikunda, Dist-Jagatsinghpur. In this connection your premises was inspected by the officer of Odisha Fire Service and found that the said buildings (i.e. Block-1, 2, 3 & 4) are functioning a single storied building, having a height of 03 mtr each and total built up area of each block is less than 1000m².

In view of the above observations, at present the said educational buildings doesn't covered under the purview of Rule-9(1) of Odisha Fire Prevention and Fire Safety Rules, 2017 r/w Odisha Fire Prevention and Fire Safety (Amendment) Rule-2019. Hence, Fire Safety Certificate is not required for the said occupancies. However the owner of the building or parties to agreement must provide minimum requirements for fire and life safety measures in the aforesaid buildings as per NBCI.

This report cannot be construed as on evidence in respect of right title, interest of plot over which the building is constructed. Any dispute arising out of land record or in respect of right, title, interest after this report shall be treated automatically cancelled during the period of dispute.
